## Terms of admission

### §1 Sport suitability/ fitness

1. the member assures being able to do sports. This has been proved by a doctor. The member is obligated to go to medical examinations regularly regarding the ability to do sports. Any illness like pain, dizziness or indisposition must be told immediatly. The request of a trainer to consult a doctor must be followed.
2. the member confirms to be aware about the increased risk of injuries and ailments which come along with physical training. The member confirms that the training at Kardia e.V. takes place with this awareness and at own risk.
3. All questions to the state of health and environment are answered truthfully and completely. The trainers are informed about any changes.
4. Kardia e.V. is not responsible for any health damages which happen as a consequence of hidden or untold diseases or on own fault.

### §2 Accountability

1. Kardia e.V. and the trainers distance themselves from any damages which are not a consequence of a careless or willfull neglect of duty.
2. The member is in responsibility to be insured in case of accidents or injuries which might happen in training as well as on the way to the trainings.
3. There is a liability insurance of Kardia for possible claims of the member.
4. Furthermore an indemnity is granted to board members, replacements or any other representatives by acclamation at the expense of the club.

### §3 Protection of Privacy

1. The member agrees to the storage, delivery and converting of personal data for the purposes of the club according to the data security regulation by *Bundesdatenschutzgesetz* (BDSG). The data will be protected from the view of thirds. Data will be used only for the purposes of the association in case that there are no hints that there are interests of the member which require protection.
2. The managment team does publish special occasions of the happenings in the club, especially concerning events or results of tournaments. Therefore personal data, texts, pictures and videos can be published. The single member does have the possibility to formulate written objects against publications. In this case publications are cancelled.
3. Every member does have the possibility to get information about own personal data. After a cancellation of the membership these data will be deleted. Personal data which is related to the cash managment will be saved for 10 years, according to the regulations of tax law. Only members of the managment team or members who do have a special function which requires certain data do have access to personal data of members.
